

Updated monthly; last revision 08/20/20




Tennessee had a
9.5% unemployment rate in July 2020, a
decline from June's
9.6% unemployment rate. Tennessee's rate remains about one
half percent lower
than the nation.

• The U.S. unemployment rate continues to fall. The 10.2% July unemployment rate remains higher than any other time since the Great Depression, but is a notable decline from the 14.7 percent peak.



#### Figure 2: Tennessee Total Nonfarm Employment Growth

Total Non-farm Tennessee June employment is down 5.1% compared to last year. Tennessee has seen a decline across most sectors, with Leisure & Hospitality down 14.3% and Manufacturing down 9.5% from last year.

The U.S. added 1.8 million jobs in July, though employment remains 7.5% below last year. The greatest decline has been in Leisure & Hospitality, falling by 24.2%.
Employment has fallen by more than 10% in Information, Other Services, Mining & Logging.






 Sales taxes increased a robust 6.3 percent in July after falling steeply the previous three months. Tax collections are based on sales during the previous month. For this period many business throughout the state had fully reopened. Tennessee continues to see significant purchases of goods with consumption reductions likely strongest in nontaxable services, such as travel.


Total tax revenues

mid-March, rising
11.9 percent in
January, 6.8 percent
in February and
6.3 percent in March.

 Total tax revenues were up an astounding 59.1 percent in July, after falling for the previous three months. July tax collections are elevated because deadlines for filing several taxes had been moved to July.


 Unemployment rates are higher in all Tennessee counties than last July. Seventeen counties had rates above 10 percent, compared with 31 counties in June. High rates are spread across the state, but rates tend to be somewhat lower across counties along the northern state border.



Updated monthly; last revision 8/27/20





• Ninety-two of Tennessee's counties saw sales taxes rise in June. Many counties saw very high growth rates leading up to COVID-19, in part because the sales tax on remote sales is now being collected on a destination basis. The pattern continued in June with 20 counties seeing revenues grow more than 30 percent.

•Moore, Davidson and Sevier counties saw very large sales tax decreases.
