

• Tennessee had a 5.1% unemployment rate in January, a decrease from December's 5.6% rate. Tennessee's rate has declined dramatically from its 15.5 % peak.


• The U.S. unemployment rate fell to 6.3% in January, a notable decline from the 14.7% peak in April.

national average.


The U.S. gained 49,000

below last year. The greatest
decline has been in Leisure
& Hospitality, falling by
22.7%. Employment has
fallen by more than 10% in
Mining & Logging.

Note: Data by month of collection.



 Sales taxes increased 9.4 percent in January, after rising 6.6 percent in December and 7.1 percent in November. Tax collections are based on sales during the previous month. Tennessee continues to see significant purchases of most goods with consumption reductions strongest in eating and drinking places and nontaxable services, such as travel. Sales tax growth was increased by marketplace facilitators being required to collect sales taxes for the first time.


• Total tax revenues rose very rapidly until mid-March, 2020.

Total tax revenues

were up 7.7 percent in January. Sales, corporate taxes and privilege taxes grew very rapidly, while some other taxes fell. July tax collections were elevated and April collections lowered because deadlines for filing several taxes were delayed until July.

 Sales taxes rose in 92 counties in December. Many counties had very high growth rates leading up to COVID-19, in part because the sales tax on remote sales is now being collected on a destination basis. The pattern continued in December with revenues growing faster than 25 percent in 23 counties.

 Only Davidson and Moore counties have experienced a sales tax decrease for the fiscal vear to date.




 Six counties had lower unemployment rates in January 2021 than the previous year. The rate was more than 2 percent higher than last year in only three counties.



• Eight counties had higher employment in January 2021 than the previous year. About two-thirds of counties have lost between 1.5 percent and 4.5 percent of their employment over the year. Unemployment rates tend to be lowest in middle Tennessee but these counties generally have significantly lower employment than last year.
