

Tennessee's rate has declined dramatically from its 15.5 % peak.


• The U.S.

unemployment rate fell to 6.0% in March, a notable decline from the 14.7% peak in April. Tennessee's rate is much below the national average.

Total non-farm Tennessee March employment is 2.7% lower than last year.
Tennessee has seen decline across most sectors, with Leisure & Hospitality down 12.6% and Manufacturing 2.0% lower than last year.
Tennessee's employment losses are much lower than the national average.

• The U.S. gained a remarkable 916,000 jobs in March, though employment remains 4.5% below last year. The greatest decline has been in Leisure & Hospitality, falling by 14.6%.





 Sales taxes increased 7.5 percent in March, after rising 15.7 percent in February and 9.4 percent in January. Tax collections are based on sales during the previous month. Collections by marketplace facilitators have significantly increased sales tax revenues. Building materials, catalog sales, general merchandise, and vehicles all showed very strong growth during January (February's collections).



• Sales taxes rose in 91 counties in March. Most counties are seeing strong revenue growth because of marketplace facilitator remittance combined with the sales tax now being collected on a destination basis. Forty-three counties saw revenue growth above 20 percent in march.

• Only Davidson and Moore counties have experienced a sales tax decrease for the fiscal year to date. Eleven counties have growth above 40 percent.




• Twenty-three counties had lower unemployment rates in March 2021 than the previous year. The rate was more than 1 percent higher than last year in only six counties.

• Thirty-four counties had unemployment rates under 5 percent, with three below 4 percent. Only six counties were above 7 percent.


•Employment fell in eight regions of the state in March, but rose slightly in Greater Memphis. The state's overall employment is -2.2% below the January 2020 mark, down from -1.9% last month.
