

Updated monthly; last revision 6/17/21.




- Tennessee's unemployment rate remained at 5.0% in May. Tennessee's rate has declined dramatically from its 15.5% peak.
- The U.S. unemployment rate fell to 5.8% in May, which is a significant decline from the 14.7% peak.
 Tennessee's rate is much below the national average.



- Both the U.S. and Tennessee saw slow employment growth during May. Tennessee has not experienced as large of a dip in employment during the pandemic as the U.S., and has recovered more quickly. However, Tennessee employment still remains 2.8 percent below pre-pandemic levels.
- U.S. employment remains 5.0 percent below pre-pandemic levels, noticeably more than for Tennessee.



Figure 3: Growth in Sales & Use Tax Collections

 Sales taxes increased 51.2 percent in May, after rising 40.2 percent in April and 7.5 percent in March. Tax collections are based on sales during the previous month. Collections by marketplace facilitators have significantly increased sales tax revenues. The high growth rate in part results from this month's collections being compared to the peak



 Total tax revenues were up 59.8 percent in May, continuing the pattern since December of very strong increases. These growth rates are in part the result of this month's collections being compared to the peak of the pandemic when the state suspended or postponed a number of 2020 tax deadlines.




- Sales taxes rose in every county in May. Counties saw very strong revenue growth because of marketplace facilitator remittance combined with the sales tax now being collected on a destination basis and the comparison with the peak of the pandemic. Only 26 counties had less than 30% growth in May and eight grew more than 60%.
- Every county has seen sales tax revenue growth for the entire fiscal year. Ten counties have growth above 40%.

- Unemployment rates of 4% or less were reported in 22 counties, up from just 3 counties in March. Rates over 5% were observed in 24 counties in May, the same as April.
- Unemployment peaked in April, 2020. As a result, every county showed more than an 3 percentage point decrease in the unemployment rate over past year.







Figure 7: Regional employment change from January 2020 (pre-COVID peak)




•All nine regions of the state saw month-over-month employment gains for second month. East Tennessee was the only region above the January 2020 employment level.

• Every county in the state saw employment growth compared with the pandemic economy during May 2020. One-third of the counties grew by over 12% compared to a year ago and 6 grew in excess of 16%. Sevier County's 30.5% pace led the state. Decatur, Hardeman, Bradley and Polk counties saw less than 4% increases.
